- Article 1:** To elect a Moderator for the ensuing year.
- Article 2:** To hear and act upon the reports of the town officers for the past year.
- Article 3:** To elect all town officers as required by law and to fill all vacancies that may occur at or prior to said meeting.

- Article 8:** Shall the Town of Bradford vote on all public questions by Australian ballot pursuant to 17 V.S.A. § 2680(b)?
- Article 9:** Shall the Town of Bradford appropriate the sum of \$2,500 to support the Northeast Slopes?
- Article 10:** Shall the Town of Bradford appropriate the sum of \$10,000 to support the Orange East Senior Center?
- Article 11:** Shall the Town of Bradford appropriate the sum of \$8,000 for the support of Tri-Valley Transit, Inc.?
- Article 12:** Shall the Town vote to raise and appropriate from the general fund the sum of THIRTEEN THOUSAND NINE HUNDRED DOLLARS (\$13,500) to help support the home health, maternal and child health, and hospice care provided in patients' homes and in community settings by the VISITING NURSE AND HOSPICE FOR VT & NH.

Article 16: To adopt a budget for the Bradford Water and Wastewater systems for the year 2023. (Only resident ratepayers of the Bradford Water and Sewer checklist may vote on this article.)

Article 17: Shall the Bradford Water and Sewer Department elect its commissioners by Australian ballot pursuant to 17 V.S.A. § 2680(b)? (Only resident ratepayers of the Bradford Water and Sewer checklist may vote on this article.)


Article 18: Shall the Bradford Water and Sewer Department adopt all budget articles by Australian ballot pursuant to 17 V.S.A. § 2680(b)? (Only resident ratepayers of the Bradford Water and Sewer checklist may vote on this article.)

Article 19: Shall the Bradford Water and Sewer Department vote on all public questions by Australian ballot pursuant to 17 V.S.A. § 2680(b)? (Only resident ratepayers of the Bradford Water and Sewer checklist may vote on this article.)


Article 20: To transact any other business that may legally come before the Bradford Water and Sewer meeting. (Only resident ratepayers of the Bradford Water and Sewer checklist may vote on this article.)


